A Bill for an Act

ENTITLED

**THE EAST AFRICAN COMMUNITY  
APPROPRIATION ACT, 2022**

**An Act of the Community to appropriate a sum of United States Dollars ninety-one million, five hundred and seventy-nine thousand, two hundred and fifteen out of the budget of the Community to meet expenditure for the organs and institutions of the Community for the financial year ending 30<sup>th</sup> June, 2023.**

ENACTED by the East African Community and assented to by the Heads of State.

1. This Act may be cited as the East African Community Appropriation Act, 2022 and shall be deemed to have come into force on the 1<sup>st</sup> day of July, 2022. Short title and Commencement.
2. Appropriation of the sum of United States Dollars ninety-one million, five hundred and seventy-nine thousand, two hundred and fifteen is allowed out of the budget of the Community to meet expenditure of the organs and institutions of the Community, as specified in the Schedule, for the financial year ending 30<sup>th</sup> June, 2023.
