## **Chair's foreword**

The petition by residents of Chuka Igambango'mbe Constituency, regarding the delayed creation of a new administrative unit in Kiringani Location was tabled before the House pursuant to Standing Order No. 225 (2) (a) by Hon. Muthomi Njuki, MP on behalf of the petitioners.

In considering the petition, the Committee held meetings with the Hon. Muthomi Njuki, MP on behalf of the petitioners and the Cabinet Secretary, Ministry of Interior and Coordination of National Government. The meetings were aimed at responding to the issues raised in the petition.

The Committee is thankful to the Office of the Speaker and the Clerk of the National Assembly for the logistical and technical support accorded to it during its Sittings.

On behalf of the Committee, and pursuant to Standing Order, 227 it is my pleasant duty to table in the House the Report of the Departmental Committee on Administration and National Security on its consideration of a petition by residents of Chuka Igambango'mbe Constituency regarding delayed creation of a new administrative unit in Kiringani Location, Meru South Sub – County.

## **EXECUTIVE SUMMARY**

The purpose of this report was to consider and respond to the prayers sought by residents of Chuka Igambango'mbe Constituency in a petition regarding delayed creation of a new administrative unit in Kiringani Location, Meru South Sub – County. The Committee found out that the prayer sought by the petitioners is justifiable given that Karingani location comprises Ndagani, Mariani, Rukindu, Njaina and Karongoni sub-locations with a population of 18,194 persons within an area of 72.5 kms. The large population requiring National Government services poses an administrative challenge to the area Chief. Karingani location also hosts Chuka university fraternity with a population of twelve thousand (12,000) people, which was increasing with each year's enrolment of students coupled with a business community that was increasingly settling in the area, all of which has led to a steady rise in population.

The report concludes that the Ministry of interior and Coordination of National Government should create a new location in Karingani by subdividing Karingani Location into Karingani and Mariani Locations. The Ministry should also fast track the rationalization of administrative units in the Country to align them with Constituency and ward boundaries.

## **1.0 PREFACE**

- 1.1 On Wednesday 28<sup>th</sup> October, 2015, a Petition was tabled before the House pursuant to Article 119 (1) of the Constitution of Kenya 2010 and Standing Order No. 225 (2) (a) by the Hon. Muthomi Njuki, MP on behalf of residents of Chuka Igambango'mbe Constituency regarding delayed creation of a new administrative unit in Kiringani Location, Meru South Sub – County.
- 1.2 The House pursuant to Standing Order 227 referred the Petition to the Departmental Committee on Administration and National Security for preparation of the Report;
- 1.3 The Committee received the Petition on Thursday 29<sup>th</sup> October, 2015 and set out a procedure for the consideration of the petition and to report to the House within 60 days as set out in Standing order no 227(2);
- 1.4 However due to the nature of work involved in responding to the prayers sought by the petitioners the Committee sought for more time.

## **2.0 MANDATE OF THE COMMITTEE**

2.1 The Departmental Committee on Administration and National Security is established pursuant to the provisions of Standing Order No. 216 (1) and (5) with the following terms of reference:-

## **2.5 List of recommendations**

1. The Ministry of interior and Coordination of National Government should create a new location in Karingani by subdividing Karingani Location into Karingani and Mariani Locations.
2. The Ministry of Interior and Coordination of National Government should fast track the rationalization of administrative units in the Country to align them with Constituency and Ward boundaries. Further the exercise should be based on an objective and fair criteria.

### **3.0 INTRODUCTION**

- 3.1 The petition by residents of Chuka Igambango'mbe Constituency regarding delayed creation of a new administrative unit in Kiringani Location, Meru South Sub – County was tabled in the House by pursuant to Standing Order 225 (2) (a) by the Hon. Muthomi Njuki, MP on Wednesday 28<sup>th</sup> October, 2015.
- 3.2 Pursuant to the House rules, the petition was referred to the Committee 29th October, 2015 for consideration and preparation of a report within 60 days. The Committee considered the petition pursuant to the provisions of Standing Order 227.
- 3.3 The Petitioners wished to draw to the attention of the House on the following, that:
- (i) To ensure effective coordination of Government functions and services at the Sub County, there is need to have well defined geographical and administrative units;
  - (ii) The above mentioned objective was not realized in the demarcation of Kiringani location within Chuka Division which had a population of eighteen thousand,one hundred and ninety four (18194) people, within an area of 72.5 square kilometres;
  - (iii) The current headquarters of Karingani Location were in Kaanwa, which was far from upcoming market centres, thus posing a challenge to the area chief who had been overwhelmed by the heavy work load of coordinating activities in the area; and
  - (iv) Requests by the residents of Karingani to the relevant National Government organs to address the matter had not been considered.

3.2 The petitioners prayed that the National Assembly through the Departmental Committee on Administration and National Security intervenes in the matter to cause the creation of a new administrative unit in Kiringani area.

## **4.0 EVIDENCE**

### **4.1 Evidence from Hon. Muthomi Njuki, MP on behalf of Petitioners**

The Committee held a meeting with the Hon. Muthomi Njuki, MP on Thursday 11th February 2016. During the meeting the Committee informed that the proposed Karingani location currently exists as a sub location within the larger Karingani Location of Chuka Division, Karingani Ward. Karingani location comprises Ndagani, Mariani, Rukindu and Karongoni sub-locations with a population of 18,194 persons within an area of 72.5 kms. It is envisaged that the proposed Karingani Location will be in line with current administrative and electoral boundaries. The proposed administrative unit will consist of the following administrative units:

- (i) Karingani Location (Proposed)
  - (a) Ndagani Sub Location
  - (b) Njaina Location
  - (c) Rukindu Sub Location
- (ii) Mariani Location (existing currently known as Karingani)
  - (a) Mariani Sublocation
  - (b) Karongoni Sub location

The Committee was also informed that a series of consultative forums with the local political leadership including the area MP, members of the County Assembly, Chiefs, Assistant Chiefs and other opinion leaders had expressed concern and the need for the creation of a new location.

The Hon. Muthomi Njuki, MP emphasized the petitioners justification for the prayers sought and informed the Committee that currently Karingani location hosts Chuka university fraternity with a population of twelve thousand (12,000) people, which was increasing with each year's enrolment of students coupled with the growing number of business persons settling in the area, all of which had led to a steady rise in population.

He added that, the current headquarters of Karingani location which is in Kaanwa, is far from upcoming markets, thus posing an administrative challenge to the area Chief, who was occasionally overwhelmed by the workload of coordinating activities in the area. The Committee was further informed that requests to address this matter by the residents through organs of the National Government had not been considered, while the situation continues to affect efficient delivery of administrative services to the area residents.

#### **4.2. Evidence from the Cabinet Secretary, Ministry of Interior and Coordination of National Government**

The Cabinet Secretary informed the Committee that the Ministry had received over 500 petitions for delineation of various administrative units across the country. The Ministry had commenced the process of rationalization and harmonization of all administrative units. The creation of administrative units would be based on recommendations from the exercise. The process would however depend, among other factors, on budgetary allocations to the Ministry.

The Hon. Muthomi Njuki, MP, who was in attendance, informed the Committee that with the development of Chuka University there was increased population growth in Kiringani Location which required services yet the residents administratively report to a chief who was based in a different ward. He further stated that Kiringani Location has five sub - locations. He further requested the Cabinet Secretary to consider fast tracking the creation of the new administrative unit. The Cabinet Secretary promised to consider the request and asked the Hon. Muthomi Njuki, MP to provide copies of the County Commissioner's recommendations on the matter and which the Member agreed to provide.

## **5.0 COMMITTEE OBSERVATIONS**



The Committee made the following observations from evidence adduced in the meetings, that:-

1. Karingani location comprises Ndagani, Mariani, Rukindu and Karongoni sub-location with a population of 18,194 persons within an area of 72.5 kms. The large population requiring National Government services poses an administrative challenge to the area Chief. Hence the prayer by the petitioners that the location be divided into two is justifiable.
2. Karingani location hosts Chuka university fraternity with a population of twelve thousand (12,000) people, which was increasing with each year's enrolment of students coupled with a business community settling in the area, all of which has led to a steady rise in population in that area.
3. To rationalise political and administrative boundaries the residents of Karingani proposed that the location be subdivided into two locations Karingani and Mariani to correspond with the existing Karingani and Mariani wards.

## **6.0 COMMITTEE RECOMMENDATIONS**

In response to the prayers by the petitioners, the Committee recommends that:-

1. The Ministry of interior and Coordination of National Government should create a new location in Karingani by subdividing Karingani Location into Karingani and Mariani Locations.
2. The Ministry of Interior and Coordination of National Government should fast track the rationalization of administrative units in the Country to align them with Constituency and Ward boundaries. Further the exercise should be based on an objective and fair criteria.









The meeting was called to order at 10.30 am. A prayer was said by Mr. Leonard Machira.

### MIN.NO.011/ANS/2016 - CONFIRMATION OF MINUTES

The agenda item was deferred.

### MIN.NO.012/ANS/2016 - PETITION BY HON. FLORENCE KAJUJU, MP ON BEHALF OF THE RESIDENTS OF MERU COUNTY REGARDING CASES OF INSECURITY, BOUNDARY CONFLICT, CATTLE RUSTLING, SEXUAL ABUSE, LOSS OF LIFE AND PROPERTY.

Hon. Florence Kajuju, MP informed the Committee that Meru County had been experiencing rising cases of insecurity, involving cattle rustling and destruction of property. The most affected Sub-Counties were Tigania East, Tigania West, Igembe Central and Igembe North which border Isiolo County. The residents of Meru County had lost animals, houses had been burnt, and crops destroyed, rape cases reported and young people shot dead. Although the cases had been reported to the police no tangible action has been taken.

Residents in the affected areas had fled their homes fearing for their lives, children had missed classes and business had come to a standstill. The attacks were reportedly fueled by border conflicts, inadequate grazing lands and water for the animals, lack of enough security personnel and negligence by police officers.

The Members of Parliament in Meru County had facilitated the construction of police camps in the affected areas. In Igembe North, the camps included Bulu, Kiumone, Luthaya and Mbiriata. Nginyo and Malaene/Kubisira camps were still under construction. In Igembe Central more camps had been established which included Mbataru, Mariara and Kiruyu which is under construction.

The Petitioner prayed that the Committee:-

- (i) Visits Meru County to assess the situation in relation with the prayers sought by the petitioners.
- (ii) Resolves that the Ministry of Internal Security and National Coordination enhance security in the conflict areas, with additional Kenya Police Reservists, Anti-Stock Theft Unit, and Rapid Deployment Unit.

- (iii) Resolve that damages suffered and loss of life, displacements, loss of property and destruction be quantified and fully compensated.
- (iv) That a proper mechanism is put in place to prevent conflicts and conflict resolution measures be established.

The Committee resolved to visit the affected areas in Meru and Isiolo Counties to assess the prevailing situation. Hon. Florence Kajuju was tasked to advise the Committee on the legal framework on compensation of the victims, who have lost their animals, crops, their lives, incidences of rape and kidnappings.

The meeting was called to order at 10.30 am. A prayer was said by Mr. Leonard Machira.

### MIN.NO.011/ANS/2016 - CONFIRMATION OF MINUTES

The agenda item was deferred.

### MIN.NO.012/ANS/2016 - PETITION BY HON. FLORENCE KAJUJU, MP ON BEHALF OF THE RESIDENTS OF MERU COUNTY REGARDING CASES OF INSECURITY, BOUNDARY CONFLICT, CATTLE RUSTLING, SEXUAL ABUSE, LOSS OF LIFE AND PROPERTY.

Hon. Florence Kajuju, MP informed the Committee that Meru County had been experiencing rising cases of insecurity, involving cattle rustling and destruction of property. The most affected Sub-Counties were Tigania East, Tigania West, Igembe Central and Igembe North which border Isiolo County. The residents of Meru County had lost animals, houses had been burnt, and crops destroyed, rape cases reported and young people shot dead. Although the cases had been reported to the police no tangible action has been taken.

Residents in the affected areas had fled their homes fearing for their lives, children had missed classes and business had come to a standstill. The attacks were reportedly fueled by border conflicts, inadequate grazing lands and water for the animals, lack of enough security personnel and negligence by police officers.

The Members of Parliament in Meru County had facilitated the construction of police camps in the affected areas. In Igembe North, the camps included Bulu, Kiumone, Luthaya and Mbiriata. Nginyo and Malaene/Kubisira camps were still under construction. In Igembe Central more camps had been established which included Mbataru, Mariara and Kiruyu which is under construction.

The Petitioner prayed that the Committee:-

- (i) Visits Meru County to assess the situation in relation with the prayers sought by the petitioners.
- (ii) Resolves that the Ministry of Internal Security and National Coordination enhance security in the conflict areas, with additional Kenya Police Reservists, Anti-Stock Theft Unit, and Rapid Deployment Unit.

- (iii) Resolve that damages suffered and loss of life, displacements, loss of property and destruction be quantified and fully compensated.
- (iv) That a proper mechanism is put in place to prevent conflicts and conflict resolution measures be established.

The Committee resolved to visit the affected areas in Meru and Isiolo Counties to assess the prevailing situation. Hon. Florence Kajuju was tasked to advise the Committee on the legal framework on compensation of the victims, who have lost their animals, crops, their lives, incidences of rape and kidnappings.

**MIN.NO.013/ANS/2016** - **PETITION BY HON. MUTHOMI NJUKI, MP**  
**ON BEHALF OF RESIDENTS OF CHUKA IGAMBANG'OMBE CONSTITUENCY ON**  
**DELAYED CREATION OF A NEW ADMINISTRATIVE UNIT.**

Hon. Muthomi Njuki, MP informed the Committee that the proposed Karingani location currently exists as a sub location within a larger Karingani Location of Chuka Division, Karingani Ward. Karingani location comprises Ndagani, Mariani, Rukindu and Karongoni sub-location with a population of 18,194 persons within an area of 72.5 kms. A series of consultative forums with the local political leaderships including the area MP, members of the County Assembly, Chiefs, Assistant Chiefs and other opinion leaders had expressed concern and the need for a new location by the name of Karingani location.

The Petitioner called the attention of the Committee to the following issues:-

- (i) That, to ensure effective coordination of National Government functions and services at the sub-county levels, there is need to have well defined geographical and administrative units;
- (ii) That, this objective was not realized in delimitation and demarcation of boundaries for Karingani location which currently exists in Chuka division and has a population of eighteen thousand, one hundred and ninety four (18,194) people, within an area of 72.5 square kilometers;
- (iii) That, currently Karingani location hosts Chuka university fraternity with a population of twelve thousand (12,000) people, which was increasing with each year's enrolment of students coupled with a business community settling in the area, all of which has led to a steady rise in population in that area;
- (iv) That, the current headquarters of Karingani location which is in Kaanwa, is far from upcoming markets, thus posing an administrative challenge to the area Chief, who is occasionally overwhelmed by the workload of coordinating activities in the area;
- (v) That, requests to address this matter by the residents of Karingani area through organs of the National Government have not been considered, while the situation continues to hamper and complicate delivery of administrative services to the area residents.

## MIN. NO.059 /ANS/2016: SUBMISSIONS BY THE CABINET SECRETARY ON PETITIONS

The Cabinet Secretary, Ministry of Interior and Coordination of National Government in response to petitions before the Committee, stated that:-

1. **Petition by residents of Dakabaricha Location regarding revocation of the appointment of Mr. David Mulato as the Chief of Dakabaricha Location, Saku Constituency.**

The Deputy County Commissioner, Marsabit Central Sub County chaired a panel that conducted interviews for the position of the Chief Dakabaricha Location on 26<sup>th</sup> January, 2015. The best four candidates, Mr. Omar Jillo Sage, Mr. David Mulato Ndonche, Ms. Amina Aila Ote and Mr. Yohana HirboBaqe in that order, were all residents of the Dakabaricha Location and members of the Burji ethnic community.

Before the appointments could be finalized, the Hon. Col (Rtd) Dido Ali Rasso, MP allegedly objected to the appointment proposed Mr. Halkano Dambi for the position. However, Mr. Halkano Dambi was not among the candidates shortlisted for interview leading to appointment to the position.

Mr. Omar Jillo Sage who emerged as the best candidate during the interviews had worked as an assistant chief in Dakabaricha Sub County from 1997 to the present day. However, at one time during his employment he was suspended and charged in a court of law for the offence of incitement to violence. He was acquitted by the court and later reinstated to his current position of Assistant Chief.

In view of the past record of Mr. Omar Jillo Sage and considering the person proposed by the Hon. Col (Rtd) Dido Ali Rasso, MP had not been shortlisted for the interviews. Mr. David Mulato Ndonche, who was ranked second in the interviews, was appointed as the chief Dakabaricha Location on 20<sup>th</sup> April, 2015. Mr. David Mulato Ndonche attained C- (Minus in KCSE, though the minimum academic requirement as per the scheme of service is C+ (plus). However, the Public Service Commission granted a temporary waive on academic requirements to facilitate appointment of applicants who had a minimum of Kenya Certificate of Primary Education to the existing vacancies in the grade of Chief and Assistant Chief in Marsabit County.

The Cabinet Secretary further informed the Committee that the recruitment and selection process were well managed and appealed to the Committee to recommend that the Ministry upholds the appointment of Mr. David Mulato Ndonche to the position of Chief, Dakabaricha location. He further stated that the assertions made by Hon. Col (Rtd) Dido Ali Rasso, MP that the residents of Dakabaricha Location had serious reservations on the appointment were not accurate. Noting that the location was predominantly occupied by the Burji Community and Mr. David Mulato Ndonche is a member of the same community. He further stated that since the Chief started working in 20<sup>th</sup> July, 2016 no single incident of demonstration by locals over the appointment had been reported.

## **2. Kiseku Ward village managers regarding alleged compensation for services offered.**

Cabinet Secretary informed the Committee that the Government was not aware of the position village managers. However, it was aware of the position of village elders. Though the Government recognized the crucial role that the village elders play, it does not facilitate them because;-

- The Ministry had no budgetary allocation for the payment of allowances;
- Most village elders were outside the employable age bracket approved by the government; and
- The size of the villages had not been standardized.

The Cabinet secretary requested Parliament to set up a fund to facilitate the operations of the village elders in recognition of the important role they play by providing an important link in the National Government service delivery.

The Committee observed that the ward administrators employed by the County governments were well remunerated and if the same was not availed to National Government administrators including the village elders the National Government risked losing this vital link in the provision of National Government services to the public. Further the village administrators were being utilized to mobilize the public and drive the agenda of the County Governments.

The Cabinet Secretary informed the Committee that the Ministry had introduced a scheme of service for the National Administration Administrators which would provide opportunities of promotion, particularly for the Chiefs and Assistant Chiefs. The Committee proposed that the facilitation of village elders to be included as a budgetary item in the Ministry's Budget for the 2016/17 Financial Year.

### **3. Petition by Hon. Muthomi Njuki, MP on behalf of the residents of Chuka IgambaNg'ombe Constituency on the delayed creation of a new administrative unit in Karingani location, Meru South Sub county**

The Cabinet Secretary informed the Committee that the Ministry had received over 500 petitions for delineation of various administrative units across the country. The Ministry had commenced the process of rationalization and harmonization of all administrative units. The creation of administrative units would be based on recommendations from the exercise. The process would however depend, among other factors, on budgetary allocations to the Ministry.

The Hon. Muthomi Njuki, MP informed the Committee that with the development of Chuka University there was increased population growth in Karingani Location which required services yet the residents administratively report to a chief who was in a different ward. He further stated that Karingani Location has six sub locations. The Cabinet Secretary requested copies of the County Commissioners recommendations on the matter and which the Hon. Muthomi Njuki, MP agreed to provide.

The Hon. Muthomi Njuki, MP also stated that the recent public sacking of some Chiefs in Meru County had been perceived as humiliating by officers by residents. The Cabinet Secretary responded that the sacking of the Chiefs was done under his directive to serve as an example to other officers on the need to ensure the eradication of illicit brews.



4. **Petition by Hon. Jessica Mbalu, MP on behalf of residents of Kibwezi East Sub County on the relocation of the sub county's headquarters.**

The Cabinet Secretary informed the Committee that Kibwezi East and Kibwezi West Sub Counties do not exist. He further stated that the boundary review process by the Independent Electoral and Boundaries Commission split the former Kibwezi Constituency into two, Kibwezi East and Kibwezi West. Kibwezi East Constituency was within Kibwezi Sub County but Kibwezi West Constituency straddles across Makindu, Nzaui and Kibwezi sub counties. The Headquarters of Kibwezi Sub County is Kibwezi Market which is shared by two Constituencies, Kibwezi East and Kibwezi West.


The Committee was further informed that residents of Kibwezi East Constituency had agitated for the Headquarters to be moved to Kambu Market but this had been opposed by the residents of Kibwezi Division. Further the National Government had made significant infrastructural developments, office constructions and fencing at the current headquarters at Kibwezi Market. The National Government was also in the process of aligning electoral and administrative boundaries and once this was done, the local leaders and residents could agree on the location of the headquarters.

The Committee observed that if indeed Kibwezi Market was located in Kibwezi West Constituency then the residents of Kibwezi East Sub County had been denied access to National Government services within their Constituency. The Cabinet Secretary requested for more time to investigate the matter and forward the findings to the Committee. The Committee recommended that if the Headquarters were to be moved to Kambu Town, the process should be gradual to allow for the development of necessary infrastructure.

3. To rationalise political and administrative boundaries the residents of Karingani proposed that the location be subdivided into two locations Karingani and Mariani to correspond with existing Karingani and Mariani wards.

**Recommendations**

The Committee recommended that:-

The Ministry of interior and Coordination of National Government should create a new location in Karingani by subdividing Karingani Location into Karingani and Mariani Locations.

The Ministry of Interior and Coordination of National Government should fast track the rationalization of administrative units in the Country to align them with Constituency and Ward boundaries. Further the exercise should be based on an objective and fair criteria.

## **DELAYED CREATION OF A NEW ADMINISTRATIVE UNIT IN KARINGANI LOCATION, MERU SOUTH SUB COUNTY**

**Mr. Chairman,** Hon. Muthomi Njuki, M.P. for Chuka/Igamba Ng'ombe Constituency, presented a petition on behalf the residents of his constituency on the delayed creation of a new administrative unit in Karingani location, Meru South Sub County.

In the petition he noted that:


- i. For effective coordination of National Government functions and services at the Sub county levels, there is need to have well defined administrative units;
- ii. The above objective was not realized in delimitation and demarcation of boundaries for Karingani location in Chuka division which has a population of 18,194 people in an area of 72.5 Km<sup>2</sup>;
- iii. Currently Karingani location hosts Chuka University fraternity with a population of 12,000 people and expected to increase annually;
- iv. The current headquarters of Karingani location at Kaanwa is far from the upcoming market and poses administrative challenges for the area chief;
- v. Requests to address this matter through National Government organs have not been considered; and,
- vi. Issues in respect to this petition are not pending before any court of law.

**Mr. Chairman,** I wish to respond as follows:

The Ministry has received over 500 petitions for delineation of various administrative units across the country. In line with constitutional provisions, the Ministry is restructuring Provincial administration and among the activities pursued is the rationalization and harmonization of administrative units. The creation of administrative units will be based on recommendations that will come from that exercise.

**Mr. Chairman,** after the harmonization and rationalization, creation of additional administrative units will depend on among other factors, the budgetary allocations to the Ministry.
