### THE SUPPLEMENTARY APPROPRIATION ACT, 2003

#### No. 1 of 2003

Dated of Assent: 16th April, 2003

Date of Commencement: 17th April, 2003

An Act of Parliament to authorize the issue of certain sums of money out of the Consolidated Fund and their application towards the service of the years ending on the 30th June, 1997 and the 30th June, 2003, and to appropriate those sums for certain public services and purposes

ENACTED by the Parliament of Kenya, as follows:—

1. This Act may be cited as the Supplementary Appropriation Act, 2003.

2. The Treasury may issue the sum of sixty-seven million, eight hundred and seventy-one thousand, three hundred and sixty-seven pounds, four shillings and seventy cents, out of the Consolidated Fund and apply it towards the supply granted for the service of the year ending on the 30th June. 1997.

3. The Treasury may issue the sum of eighteen billion, one hundred and seventy-seven million, eight hundred and sixty-three thousand, six hundred and twenty-eight shillings, out of the Consolidated Fund and apply it towards the supply granted for the service of the year ending on the 30th June, 2003.

- 4. (1) The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the First Schedule, in the amounts respectively specified in the third column of that Schedule.
- (2) The sum granted by section 3 shall be appropriated for several services and purposes specified in the second column of the Second Schedule, in the amounts respectively specified in the third column of that Schedule.
- 5. In addition to the sum granted by section 3, the sum specified in the fourth column of the Second and Third Schedules shall be applied for the several services and purposes specified in the second column of those Schedules, out of revenue directed to be applied as Appropriations in Aid under section 11 of the Exchequer and Audit Act.
